Open Discussion – Community Needs

- Continued discussion around minority/immigrant support.
 - The Food Bank shared that most pantries are not requesting documents, unless they have to based on federal funding.
 - o Deborah Lee (Safe Harbor of Sheboygan County) and Paul Aparicio (Love INC and Grace Episcopal Church) will connect regarding minority and immigrant support and possible support group.
- Sharing of translation services was brought up.
 - o Food Bank will reach out to pantry leadership to determine if any of them may be able to translate.
 - Safe Harbor is willing to be a resource for translation services and video clips discussing your services and support available related to COVID-19 in Hmong and Spanish speaking languages. This is being offered to assist in providing accessible services during this crisis to these populations. Reach out to Deborah Lee, Executive Director of Safe Harbor via e-mail at deborahl@sheboygansafeharbor.org if you are interested in utilizing their advocates in that way.
- LOVE Inc is working with the Food Bank to deliver food boxes to individuals who are unable to pick up their boxes. Meals on Wheels continues to be an option for the homebound to receive prepared meals.
- LOVE Inc is putting a call out to pastors this week for them to be able to better respond to grief during this time.
- Salvation Army has created an Emotional & Spiritual Care Line; they are available 9AM-9PM 7 days a week at 1-888-651-7294.

ACTION STEPS:

- Safe Harbor will keep everyone updated on what they find relating to xenophobia and resources to share with minorities
- Boys and Girls Club will do targeting check-ins with minority club families and report back their findings.
- o LOVE Inc will update the Network on the status of the grief support they are looking to provide.
