• Lakeshore CAP will be getting rental assistance dollars through Wisconsin Rental Assistance Program starting as early as June 8. They do not have all the details yet – so more updates to come on that!

#### **Food Assistance:**

- Patrick shared that the Food Bank will be opening one new drive-thru pantry on Frontage Road at Glacier Transit Storage. (Click here for their flyer.) It will be open from 10am-Noon on Mondays and Fridays starting this Friday. This is through the CARES Act and provides fresh foods from farmers. Staples and personal care items will still be included. The fresh food will be stored onsite in a refrigerated facility. The School Meal Sites will be discontinued. These clients will be directed to the new site or other existing pantry sites. Love Inc has volunteered to deliver food to individuals/families that may not have access to transportation.
  - Help might be needed with delivery and distribution.
  - o A new part-time staff member has been hired. More volunteers will be needed.
  - o If there is an excess of fresh food, the Food Bank would like to offer to agencies that could use it.

#### **General Discussion:**

Community testing for COVID-19 is scheduled for this Thursday (11-7), Friday (11-7) and Saturday (8-4). The
testing will be done by the National Guard, but Public Health is organizing. There is a capacity for 400 tests per
day. No antibody tests will be done. There is a need for interpreters, Hmong in particular. There will be two
shifts per day, each approximately 5 hours in length. (Click here for the details.) (Click here for the Facebook
