
Sheboygan County COVID-19 Relief Fund


Volunteer Center Network



COMMUNITY IMPACT INITIATIVES

Community Partnership for Children (CPC)

\$312,000

CPC is a cradle to career initiative focused on prevention support for youth and their families. At this time, the coalition is developing the early learning portion of the initiative, which focuses on children prenatal to 5-years-old, their families and caregivers. The vision of the CPC is that all Sheboygan County children are safe, healthy, prepared to grow, learn, and achieve.

739 babies received community support before even leaving the hospital. Families had their questions answered and were provided resources and referrals. <u>View full 2019/2020 report online at uwofsc.org/our-impact.</u>

Providing Access to Healing (PATH)

\$275,000

PATH is a school-based mental health program that increases access to mental health services for youth by removing financial and geographical barriers with positive social/emotional and academic results.

Students experience:

- 96% reported increased ability to communicate thoughts and feelings
- 85% reported feeling better about life after starting counseling
- 96% made progress on treatment goals
- 100% felt their counselor treated them with respect and was caring/understanding

The 2019/2020 school year served over 575 children through 22,295 therapy sessions (a 54% increase from 2018/2019 school year). <u>View full 2019/2020 report online at uwofsc.org/our-impact.</u>




